KEVIN ENERSON – SUPERINTENDENT ISD 2689

Superintendent Kevin Enerson and School Board members Amy Nelson and Lance Oye presented information on the upcoming April 9, 2019 two question bond referendum vote to build one elementary school on the campus of the existing Middle School/High School and improve safety and security needs on the existing campus. The proposed elementary school would accommodate up to 600 students in grades PreK through 5. If the bond referendum is successful, construction would begin in April 2020 and continue through August 2021. The existing Hill and Brown school facilities would be decommissioned, demolished and the property would be sold.

Commissioners thanked Superintendent Enerson and board members for the information and attending the meeting. No action was taken.

TYLER REISCH-AUDITOR/TREASURER

Auditor/Treasurer Tyler Reisch appeared to present the Eide Bailly Audit Agreement for auditing the financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of Pipestone County as of December 31, 2018. The estimated fee for the audit would be \$26,250 for the financial statement audit and \$2,600 for the single audit. Motion by Johnson, seconded by Nath to approve the audit agreement as presented. Motion carried unanimously.

Auditor/Treasurer Reisch requested to board set March 26, 2019 at 9:45 AM for a proposed property tax abatement request from Betty Cramer, pursuant to Minnesota Statute 469.1813 and 116J.993 through 116J995 consisting of a new home construction located in Township of Sweet. Motion by Wildermuth, seconded by Kooiman to set March 26, 2019 at 9:45 am for the Public Hearing. Motion carried unanimously.

COUNTY ADMINISTRATOR -STEVE EWING

In the absence of Human Resources Coordinator Cathy Feste, Administrator Ewing reported that Mr. Nate Stoel, an internal candidate was hired as an Appraiser in the County Assessor's Office at Step 2 on the county pay plan. He will be starting his position in early April.
