Pipestone County Commissioner Meeting
July 2, 2019

The Pipestone County Commissioners met with Chairman Chris Hollingsworth, Commissioners Luke Johnson, Dan Wildermuth Bruce Kooiman, and Les Nath. County Administrator Steve Ewing was also present. Chairman Hollingsworth called the meeting to order at 9:00 AM with the Pledge of Allegiance to the Flag.

PROJECT UPDATES, PROJECTS UNDER CONTRACT, PROJECTS IN THE PLANNING STAGE

County Engineer Nick Bergman provided information on project updates, projects under contract and projects in the planning stage. Engineer Bergman also reported that the courthouse parking lot reconstruction project is set to begin on Monday July 8. Commissioners discussed the West side law enforcement driveway project. Consensus was to have Engineer Bergman prepare a change order with Martinez Concrete for the excavation and placing of aggregate material for the driveway. The driveway will allow access for Sheriff's Office vehicles from 2nd Avenue SW. Engineer Bergman also reported that the Highway Maintenance Department has been busy repairing frost boils on county gravel roads and also has been spraying ditches for weeds. \$11,000 was received from the State of Minnesota Petro Fund for reimbursement for soil testing from when the old fuel tanks were removed from the Highway Department.

EDGERTON/PIPESTONE FFA FAIRGROUNDS CHILDRENS BARN SIGN REQUEST

Mr. Nate Thompson from the Edgerton FFA attended the meeting to request that the county approve a new sign be placed on the Children's Barn at the Fairgrounds. He presented two quotes from Main Street Printers, Edgerton MN. 3ft. by 5ft. \$234.00, and 4ft. by 6ft. for \$369.00. Both quotes include shipping. Brandt and she agrees on the sign. Motion by Kooiman, seconded by Johnson to approve the purchase of the 4ft by 6ft sign. Motion carried unanimously.

CENTRAL SCHOOL DEMOLITION AMENDED ASBESTOS REMOVAL ESTIMATE

Administrator Ewing reported that he had received an updated asbestos material and steam pipe removal estimate from DRC Inc. located in the 1917 and 1939 sections of Central School. This update supersedes the estimate received at the June 25, 2019 board meeting. The estimate calls for 260-man hours at \$124.30 per hour for a total cost of \$32,318.00.

Transportation of the material would be charged to the county at \$105 per ton. A formal change order from Bolton and Menk Engineering will be forthcoming.

Motion by Nath, seconded by Wildermuth to approve the estimate as presented and that it supersedes the previous estimate. Motion carried unanimously.

PERSONNEL

Administrator Ewing reported that Danielle Thompson has accepted the position of Office Assistant/Paramedic at the EMS/EM/VSO Office. She will start the position on Monday July 8, 2019.
